

1. INTERPRETATION

1.1 In these Conditions the following words have the following meanings:

"Customer" means the firm, organisation or company who purchases services from SECG.

"SECG" Southern Euro Compliance Group is a shared EMC test facility, owned and managed by the following:

"Nominated SECG Representative" means an individual from an SECG company undertaking work on behalf of the SECG.

"Contract" means any contract between an SECG Company and the Customer for the sale and purchase of Services, incorporating these Conditions.

"Services" means any services agreed in the Contract to be supplied by a Nominated SECG Representative.

2. APPLICATION OF TERMS

2.1 Contract will be on these Terms and Conditions to the exclusion of all other terms and conditions (including any terms and conditions which the Customer purports to apply under any purchase order, confirmation of order, specification or other document).

2.2 No terms or conditions endorsed upon, delivered with or contained in the Customer's purchase order, confirmation of order, specification or other document will form part of the Contract simply as a result of such document being referred to in the Contract.

2.3 Any variation to these Conditions and any representations about the Service shall have no effect unless expressly agreed in writing between the authorised Representatives of the Customer and a Nominated SECG Representative.

2.5 No order placed by the Customer shall be deemed to be accepted by a Nominated SECG Representative until a written acknowledgement of order is issued by the same.

2.6 No order which has been accepted by a Nominated SECG Representative may be cancelled by the Customer except with the agreement in writing of the Nominated SECG Representative.

2.7 Any quotation is given on the basis that no contract will come into existence until the Nominated SECG Representative despatches an acknowledgement of order to the Customer. Any quotation is valid for a period of 30 days only from its date, provided that the Nominated SECG Representative has not previously withdrawn it.

2.8 All transactions are business to business transactions.

The Customer will abide by all health and safety requirements imposed upon him at the time of his visit.

The Customer will not carry out any work on SECG premises or using SECG equipment unless accompanied by an authorised Nominated SECG Representative.

Nominated SECG Representative will not alter, manipulate, set up, operate or otherwise interfere with the Customer's product.

The Customer's product and equipment is at the Customer's risk at all times while on SECG premises and no liability is accepted by SECG for any loss however caused.

All tests are specified by the Customer and carried out at the Customer's risk.

Test results relate only to the equipment tested and must not be used to claim product endorsement by SECG.

Test accuracy and equipment calibration traceability are maintained at a level sufficient to meet the requirements of the SECG for self-certification and pre-compliance purposes only.

SECG premises are available for booking for a minimum of 4 hours. The minimum duration of time by which the 4 hours may be exceeded is half an hour. The premises may not be booked for more than 8 hours in any one day.

All bookings must be accompanied by a purchase order number or credit card details.

In the event of the Customer cancelling a booking with less than one working day's notice, the Customer shall pay SECG half the invoice amount.
